

# Transparency in Action: Use cases of IATI data



Powering rapid responses to food and nutritional insecurity

Global Alliance for Food Security (GAFS)

In 2023, IATI partnered with the **Global Alliance for Food Security (GAFS)**, helping them use IATI data to track, monitor, and respond to the global food crisis. Founded in 2022 by the G7 Presidency, GAFS brings together over 40 institutions to catalyse swift and coordinated responses to food insecurity.

- GAFS has tracked IATI data on **7,000 activities** and **43,000 transactions** related to food and nutrition security, and shared this information on their <u>Global Food and Nutrition Security Dashboard</u>.
- IATI has already supported the data infrastructure of <u>Food Security Crisis Preparedness Plans</u> in 25 countries, driving the real-time tracking of funding and resource allocation that can save lives.



### Measuring sustainable development across Africa

African Development Bank (AfDB)

The **African Development Bank** uses IATI data as a key foundation for mapping and monitoring the transformative impact of their investments. AfDB publish IATI data on their sustainable development activities to improve transparency and decision-making.

- AfDB shares detailed data on over **5,500 projects** across **17,000 locations**, representing over **USD 184 billion**.
- AfDB showcase their IATI data on <u>MapAfrica</u> which tracks how the Bank's strategic <u>High 5 Priorities</u> are being realised across the continent.



## Tracking development cooperation across Nigeria

Federal Ministry of Finance, Budget, and National Planning, Federal Government of Nigeria

The **Government of Nigeria** uses IATI's timely data to inform budget decisions, economic planning, and monitoring of development cooperation. In 2024, Nigeria's Federal Ministry of Budget and Economic Planning launched the Nigeria Development Cooperation Dashboard, improving visibility of billions of dollars of resources.

- In 2023, 158 organisations published IATI data on development projects in Nigeria, totalling over USD 5 billion.
- Nigeria Development Cooperation Dashboard maps IATI data to Nigeria's National Development Plan pillars and the Sustainable Development Goals.



### Driving access to data across Latin America and the Caribbean

CAF – Development Bank of Latin America and the Caribbean

**CAF** has joined over 100 organisations as member of IATI and In 2024, started publishing IATI data. Their showcasing their commitment to transparency and sharing data on how cooperation among regional partners can accelerate progress towards shared development goals.

- In 2023, the bank designed its first Access to Information and Institutional Transparency Program.
- In 2024, CAF has published data on the financing of over 150 development activities across 14 countries totaling over USD 5 billion.



#### Making overseas development assistance accountable in the Netherlands

Ministry of Foreign Affairs, Government of the Netherlands

**The Netherlands** was one of the first governments in the world to publish their aid according to the IATI Standard, making billions of dollars publicly available over the years. Once aid leaves the government, the Ministry of Foreign Affairs (MFA) continue to ensure accountability.

- The MFA requires more than **500** of its implementing partners (including NGOs) to publish IATI data on where they spend Dutch aid.
- This commitment makes it easier to 'follow the money', linking a network of funding sources, partners, activities and on-the-ground results.
