## Capabilities

Remembers what user said earlier in the conversation

Allows user to provide follow-up corrections

Trained to decline inappropriate requests



## Limitations

May occasionally generate incorrect information

May occasionally produce harmful instructions or biased content

Limited knowledge of world and events after 2021

What's the purpose code for food aid?



The purpose code for food aid in the OECD-DAC system is 52010. This code is used to classify development assistance projects and programs that are primarily aimed at providing food aid to countries and populations in need. It includes activities such as the provision of emergency food aid, nutrition programs, food security programs, and food-related technical assistance. The purpose code for food aid is part of the broader sector code for agriculture, forestry, fishing, and rural development (sector code 311), which also covers activities such as agricultural research, irrigation, and rural infrastructure development.

IATI was launched in 2008 by a group of donor governments, civil society organizations, and aid recipient countries, and it has since grown to include over 100 member organizations.

According to IATI what work is Oxfam carrying out in Bangladesh?



To find out what work Oxfam is carrying out in Bangladesh according to IATI, we would need to access their published data on the IATI Registry.


